This pertains to extension of duration to complete 3-year B.Sc. in Hospitality & Administration i.e.6+2 years for 2009-2010 students. IGNOU has now agreed to accommodate students of 2009-2010 batch, who were placed OUT OF SYSTEM, because of one or two backlog papers, till June 2017, by paying Re-admission fee of Rs.4,500/- and Rs.2,700/- for NCHMT and IGNOU components, respectively to IGNOU.


As you are aware, this facility has already been extended to such students with regards to SEM-I, SEM-III and SEM-V of 3-year B.Sc. in H&HA who sat for the examinations during ODD SEMESTER TEE - 2015-2016 in November 2015. However, similar facility is now being extended to such students to clear their backlog papers of SEM-II, SEM-IV and SEM-VI of 3-year B.Sc. in H&HA in the **SPECIAL EXAMINATION**, proposed to be conducted by NCHMCT during August 2016.

In other words, students of 2009-2010 batch who had already sat for the ODD SEMESTER TEE - 2015-2016 and still have some backlog papers can clear the same by appearing in SEM-I, SEM-III and SEM-V alongwith regular students of ODD SEMESTER TEE - 2016-2017, to be held during November 2016. Similarly, students who are being accommodated in the **SPECIAL EXAMINATION** in August 2016 will have another opportunity to clear the backlog papers, if any, during EVEN SEMESTER TEE - 2016-2017, to be held during April 2017. In both the cases, this will be last chance to clear the backlog papers of ODD SEMESTER and EVEN SEMESTER, in view of expiration of eight years in 2017. No further opportunity will be available for them.

You are requested to inform such students, i.e. 2009-2010 batch, to avail this opportunity and clear the backlog papers, if any, to become eligible for award of degree. You may also like to upload this circular in your website for the benefit of students.
